On June 3, 2020, Peter Gaal signed Schedules (Doc. 70) on behalf of Procom America, LLC (the "**Debtor**"). At CM/ECF page 322 of the Schedules, a "Loan to Peter Gaal" is disclosed. The loan was in the total amount of \$351,451.74 and consisted of transfers from the Debtor (1) to Suit Supply for Mr. Gaal's benefit in the amount of \$1,451.74 on February 1, 2020 (or 90 days before the petition date); (2) to Mr. Gaal in the amount of \$250,000.00 on February 28, 2020 (or 63 days before the petition date); and (3) to Mr. Gaal in the amount of \$100,000.00 on March 10, 2020 (or 52 days before the petition date), (together, the "**Loan**"). Moreover, Mr. Gaal testified at the Meeting of Creditors that the Loan is payable on demand to the Debtor. <u>Transcript</u>, 17:13-18:24 (excerpts attached hereto).
