Steven M. Berman, Esquire and the law firm of Shumaker and Loop & Kendrick, LLP (collectively "Shumaker"), pursuant to 11 U.S.C. §§ 503 and 330; Fed.R.Bankr.P. 2016; and Local Rule 2016-1, hereby file this Second Interim Application for the Allowance and Payment of Fees and Costs to Shumaker, Loop & Kendrick, LLP as Special Counsel for the Trustee (the "Second Interim Fee Application") and, in support thereof, state as follows:

#### **Background Facts**

- 1. On May 1, 2020, Procom America, LLC dba Beyond Band of Brothers dba BBOB ("Debtor") filed its voluntary petition for relief under Chapter 7 of Title 11 of the United States Bankruptcy Code (the "Petition Date").
- 2. On May 4, 2020, Douglas N. Menchise ("Trustee"), was appointed as Chapter 7. Trustee after the Debtor's case was converted from Chapter 11 to Chapter 7.
- 3. On June 16, 2020, the Trustee filed his Application for Order Approving Employment of Steven M. Berman, Esq. and the Law Firm of Shumaker, Loop & Kendrick, LLP, as Special Counsel *Nunc Pro Tunc* to June 4, 2020 (Doc. 93) ("Employment Application").
- 4. On June 18, 2020, this Court entered its Order Approving the Employment Application (Doc. 97).
- 5. On October 25, 2021, the Firm filed its First Interim of Shumaker, Loop & Kendrick, LLP for Compensation for Services Rendered and Reimbursement of Expenses as

Special Counsel to the Trustee for the Period from June 4, 2022 through September 30, 2021, (Doc. 318) ("First Interim Fee Application"), requesting approval of fees in the amount of \$149,886.50 and costs in the amount of \$4,899.28 for a total of \$154,785.78.

6. On December 2, 2021, this Court entered its Order Granting the First Interim Fee Application (Doc. 328) approving and allowing the Firm fees in the amount of \$149,886.50 and costs in the amount of \$4,899.28 for a total of \$154,785.78.

#### **Compensation Requested for the Interim Application Period**

- 7. This Second Interim Fee Application seeks the allowance and payment of fees earned and costs incurred from October 1, 2021, through September 30, 2022 ("Second Interim Fee Application Period") in the amount of \$132,084.00 in fees based on services performed during the Second Interim Fee Application Period. This Second Interim Fee Application also seeks the allowance and payment of costs incurred by Shumaker during the Second Interim Fee Application Period in the amount of \$2,991.56.

reimbursement of expenses incurred in the amount of \$2,991.56, for a total of \$135,075.56,

permitting disbursements to Shumaker in the allowed amount up to a cap on attorney's fees of no

more than 50% of the Estate's recoveries to date along with allowed expenses, and further relief

as this Court deems just and appropriate.
