#### **Directions**

From the North - From U.S. 23:

Take U.S. 23 south to I-475 east to Toledo. Follow I-475 to I-75 south. Exit I-75 at the "Downtown" (Washington Street) exit (202A). Follow Washington Street to Erie Street. Turn left on Erie Street and continue to Jackson Street (Jackson is just past the Courthouse). Turn left on Jackson and proceed along Jackson Street to the intersection of Michigan-Jackson-Can-ton-Spielbusch. Shumaker's office building is located on the right-hand side just past the intersection. Proceed on Jackson through the intersection to our driveway turnout on the right. A brick pillar marked with "Shumaker" is located at the driveway entrance.

#### From the East:

Take the Ohio Turnpike (180-190) west to the I-75 exit. Take I-75 north into Toledo. Cross the Maumee River (big grain terminals on the riverbank) and exit at the "Downtown" exit (201B). This exit will take you, by curving to the left, onto Erie Street. Fol-low Erie Street to Jackson Street (Jackson is just past the Court-house). Turn left on Jackson and proceed along Jackson Street to the intersection of Michigan-Jackson-Canton-Spielbusch. Shumaker's office building is located on the right-hand side just past the intersection. Proceed on Jackson through the intersection to our driveway turnout on the right. A brick pillar marked with "Shumaker" is located at the driveway entrance.

#### From the South:

Take I-75 into Toledo. Cross the Maumee River (big grain terminals on the riverbank) and exit at the "Downtown" exit (201B). This exit will take you, by curving to the left, onto Erie Street. Follow Erie Street to Jackson Street (Jackson is just past the Courthouse). Turn left on Jackson and proceed along Jackson Street to the intersection of Michigan-Jackson-Can-ton-Spielbusch. Shumaker's office building is located on the right-hand side just past the intersection. Proceed on Jackson through the intersection to our driveway turnout on the right. A brick pillar marked with "Shumaker" is located at the driveway en-trance.

#### From the West:

Take the Ohio Turnpike (180-190) east to the I-75 exit. Take I-75 north into Toledo. Cross the Maumee River (big grain terminals on the riverbank) and exit at the "Downtown" exit (201B). This exit will take you, by curving to the left, onto Erie Street. Follow Erie Street to Jackson Street (Jackson is just past the Courthouse). Turn left on Jackson and proceed along Jackson Street to the intersection of Michigan-Jackson-Can-ton-Spielbusch. Shumaker's office building is located on the right-hand side just past the intersection. Proceed on Jackson through the intersection to our driveway turnout on the right. A brick pillar marked with "Shumaker" is located at the driveway entrance.

#### From I-75:

Follow I-75 south to the "Downtown" (Washington Street) exit (202A). Follow Washington Street to Erie Street. Turn left on Erie Street and continue to Jackson Street (Jackson is just past the Courthouse). Turn left on Jackson and proceed along Jackson Street to the intersection of Michigan-Jackson-Canton-Spielbusch. Shumaker's office building is located on the right-hand side just past the intersection. Proceed on Jack-son through the intersection to our driveway turnout on the right. A brick pillar marked with "Shumaker" is located at the driveway entrance.

#### From I-75 (Alternate):

Follow I-75 south to I-280 south to the Greenbelt Parkway exit (11). Continue straight on the Greenbelt Parkway. When you get to Cherry Street (about 2 miles), the Greenbelt Parkway chang-es to Spielbusch Street. Proceed on Spielbusch to Jackson Street. Turn right on Jackson. Shumaker's office building is on the right-hand side as you turn onto Jackson Street. A brick pillar marked with "Shumaker" is located at the driveway entrance.
