## ASSIGNMENT FOR THE BENEFIT OF CREDITORS

The Assignee shall take possession of, and protect and preserve, all such assets and administer the Estate in accordance with the provisions of chapter 727, Florida Statutes, and shall liquidate the assets of the Estate with reasonable dispatch and convert the Estate into money, collect all claims and demands hereby assigned as may be collectible, and pay and discharge all reasonable expenses, costs, and

disbursements in connection with the execution and administration of this assignment from the proceeds of such liquidations and collections.
