Meet the 2024 class of Power 100 – influential executives, developers and behind-thescenes power players from across the Tampa Bay region.

The annual Power 100 list, which launched in 2016, is curated by the Tampa Bay Business Journal's publisher and editorial staff.

These business leaders set the agenda in Tampa Bay. Some have been on the list every year since its inception; others are new. The Power 100 list is not a ranking but rather a guide that aims to reflect the most influential businesspeople in Tampa Bay at this moment in time.

To narrow down the list, the team assessed not only organizational leadership but also those who, either visibly or quietly, through philanthropic or institutional means, shape the path and fortunes of the regional business community beyond their bubble.

The recognition represents a cumulative impact and staying power. Power, by nature, doesn't change quickly. There will be familiar names.

In 2023, we introduced the Legends class, to represent the Tampa Bay region's perennially powerful. Sixteen Legends were named in 2023, and 12 new ones joined the list this year.

The list does not include elected officials, whose power is granted by the nature of their office. Influential families and pairs appear together because they wield their influence jointly.
