## Shumaker's Michele Leo Hintson Selected by the Florida Bar to Serve on Two Committees

The Committee offers assistance to the Governor with organizing and presenting an annual training program for all JNC commissioners, which provides authoritative information on judicial selection and the judicial nominating process. It also acts as a forum for the mutual exchange of information amongst the commissioners.
