Each year, the research team at *Super Lawyers* undertakes a rigorous multi-phased process that includes a statewide survey of lawyers, independent research evaluation of candidates, and peer reviews by practice area. Only 5% of Ohio attorneys have been selected for inclusion in *Super Lawyers*.

The Rising Stars selection process is identical to the *Super Lawyers* process, with one exception: to be eligible, a candidate must be either age 40 years old or younger, or in practice for 10 years or less. Only 2.5% of Ohio attorneys are selected for the Rising Stars list.
