## Tivoli Homes of Sarasota Prevails in Copyright Infringement Lawsuit against Medallion Homes Gulf Coast

**SARASOTA, Fla.** — Full-service business law firm Shumaker, Loop & Kendrick, LLP's partners **Duane A. Daiker**, a board certified appellate practice specialist, and **Christopher A. Staine**, a board certified construction attorney, recently won a copyright infringement lawsuit brought against their clients, Tivoli Homes of Sarasota, Inc. and Start to Finish Drafting, LLC.

Medallion Homes Gulf Coast brought an action in federal court against the two companies, seeking damages as a result of alleged copyright infringement arising out of Tivoli Homes of Sarasota's construction of a residence for a Sarasota couple (Medallion Homes Gulf Coast, Inc. v. Tivoli Homes of Sarasota, Inc., et al., D.C. Docket No. 8:14-cv-03117-VMC-JSS and 11<sup>th</sup> Cir. Ct. App. Case No. 15-15393).

According to the lawsuit, Tivoli Homes of Sarasota and Start to Finish Drafting obtained and used a copyright protected architectural drawing belonging to Medallion Homes Gulf Coast in connection with construction of the residence.

"The victories, both at the trial court and appellate levels, represent full vindication for our clients," said Staine. "We are pleased that both the District Court and the 11<sup>th</sup> Circuit Court of Appeal meticulously scrutinized the testimony and evidence before them and arrived at what we believed to be the only appropriate and just conclusion – that neither Tivoli Homes of Sarasota nor Start to Finish Drafting committed any wrongdoing."

Based on the strength of the evidence presented during the course of the litigation, Tivoli Homes of Sarasota and Start to Finish Drafting successfully obtained summary judgment in their favor. While noting certain similarities between Medallion Homes Gulf Coast's architectural drawings and the drawings used in connection with the Tivoli Homes of Sarasota's project, the U.S. District Court found that "at the level of

protected expression, the differences between the designs are so significant that no reasonable fact finder could determine that the works were substantially similar."

On appeal, the United States Court of Appeals for the 11<sup>th</sup> Circuit unanimously agreed with the District Court's conclusions, affirming the summary judgment in favor of Tivoli Homes of Sarasota and Start to Finish Drafting.

"The 11th Circuit Court's decision helps to further clarify federal law relating to infringement claims for copyrighted housing plans and will serve as guidance for future litigants facing similar issues," said Daiker.

According to the 11<sup>th</sup> Circuit Court of Appeal in its 9-page *per curiam* opinion, "[t]he numerous and significant differences discussed by the district court indicate that these plans differ where it matters: at the level of protectable elements."
