The Company provides family-oriented recreational and arcade entertainment at its facility on South Gulfview Boulevard, serving local residents and tourists. Captain Bligh's Landing filed a petition under Chapter 11, Subchapter V of the Bankruptcy Code (Bankr. M.D. Fla. Case No. 25-08562) on November 14, 2025, with \$2,011,893 in assets and \$317,736 in liabilities. Anastasios Anastasopoulos, president, signed the petition.

Judge Catherine Peek Mcewen presides over the case.
