COSMETIC MEDICINE: Gets Interim OK to Use Cash Collateral

The U.S. Bankruptcy Court for the Middle District of Florida entered a second interim order authorizing Cosmetic Medicine Enterprises Inc., and affiliates to continue using cash collateral.

Under the order, the Debtors are authorized to use cash collateral in accordance with the approved budget, subject to a 10% variance for any individual budget line item, to pay ordinary operating expenses, Chapter 11 administrative expenses, and other expenditures specifically approved by the Court. This authorization remains effective until a final order is entered, the court modifies or terminates the relief, or a termination event occurs.

As adequate protection, the secured creditors will be granted replacement liens on the Debtors' post-petition cash collateral with the same validity, extent, and priority as their pre-petition liens. The Debtors must also provide periodic financial reports on income and expenses.

The order preserves all parties' rights to challenge the validity, priority, or perfection of any asserted liens or to seek additional or different adequate protection.

The authorization to use cash collateral will terminate automatically if any case is converted to Chapter 7 or dismissed, a Chapter 11 trustee is appointed, or the court orders otherwise.

Cosmetic Medicine Enterprises Inc. sought protection under Chapter 11 of the U.S. Bankruptcy Code (Bankr. M.D. Fla. Case No. 26-02756) on April 3, 2026. In the petition signed by Marissa Morris Harrell, manager, the Debtor disclosed up to \$10 million in both assets and liabilities.
